### Programme Overview

---

The Masters in Social Research Methods is designed to equip students within the South Coast Doctoral Training Partnership ([www.southcoastdtp.ac.uk](http://www.southcoastdtp.ac.uk)) with the tools and methodological expertise required for independent PhD study. It has been designed with close reference to the Economic and Social Research Council's Postgraduate Training and Development Guidelines Second Edition 2015 (available at <http://www.esrc.ac.uk/files/skills-and-careers/studentships/postgraduate-training-and-development-guidelines-2015/>).

### Brief outline of the programme

The Masters in Social Research Methods (MSRM) has been developed to provide training on a wide range of research methodologies, coupled with subject specific teaching. The programme is designed to make sure that you will have the skills, curiosity and creativity to be truly innovative when conducting research within the broad remit of the social sciences. The programme has interdisciplinarity running through its core, ensuring that after graduation you will be able to work in interdisciplinary teams and to communicate research ideas and findings clearly to a range of audiences. It will enable the next generation of social scientists to undertake high-quality analytical work, handle and understand different forms of data and collaborate with others.

Modules that will be taken during the programme cover three main areas. You will have the opportunity to study modules on research strategy and methodology, including philosophy of social science research, research and survey design, and qualitative and quantitative methods. These are balanced by subject specific modules that are related to your future PhD research subject area. Finally, you will undertake an interdisciplinary module that will ensure that you understand different strategies and ways to conduct research within your broad research area.

Most students will be able to choose modules that will aid in their future research plans from across all partner universities. There is flexibility for you to choose modules to suit your needs in conjunction with your prospective PhD supervisors that will prepare you for your PhD research.

Your contact hours will vary depending on your module/option choices. Full information about contact hours is provided in individual module profiles.

## **Learning and teaching**

The programme will use a variety of teaching and learning methods. These will include lectures that are audio-recorded and streamed online, student-led seminars, computer workshops, library sessions, supervised independent research and independent study. Module sessions may range from large lectures to small-group seminars and workshops, which provide excellent opportunities for discussion. You will be expected to prepare oral presentations and to lead discussions, thereby developing your skills in written and oral presentation. Occasionally module content may be delivered outside of the university campuses and involve visits to non-academic partners or fieldwork activities.

All modules will be audio-recorded and, where possible, streamed online via a web portal, allowing learning to take place remotely. For 2018-19, small group tutorials will occur at Southampton, organised to ensure accessibility for all students from both Portsmouth and Southampton. The University of Brighton will be running their own standalone SCDTP Masters and will not be attending this Masters. However the option to do this is still listed in this document.

All programme modules have their own site on Blackboard, and all students are able to access materials (lecture slides and recordings of live lectures, coursework details, references and module updates) to supplement their classroom taught lectures. Modules at Brighton and Portsmouth will have this information on their local learning sites (Blackboard in Brighton; Moodle in Portsmouth), with restricted information on Southampton's Blackboard site.

Each module within the programme has learning and teaching methods that have been designed to ensure that the learning outcomes of that module will be achieved.

## **Assessment**

You will experience a range of assessment methods throughout the programme. These will include a combination of traditional and more innovative assessment methods, including written coursework (e.g. essays, examinations book reviews, blogs and policy briefs), problem sets, practical exercises, and oral presentations. These are all designed to enhance your skills and prepare you for PhD research.

## **Special Features of the programme**

The Masters programme is based in Southampton, but is part of the South Coast Doctoral Training Programme, between the Universities of Southampton, Brighton and Portsmouth. Some modules will take place across all three universities and there may be the possibility to choose modules in any of the partner universities (where available and applicable – please discuss with the programme director). Hence you will be expected to travel between sites on occasion, experiencing the best teaching in all locations.

Please note: As a research-led University, we undertake a continuous review of our programmes to ensure quality enhancement and to manage our resources. As a result, this programme may be revised during a student's period of registration; however, any revision will be balanced against the requirement that the student should receive the educational service expected. ## **Educational Aims of the Programme**

---

The aims of the Social Research Methods programme are to train you in a wide range of research methodologies to prepare you for PhD study. This will be aligned with specific subject specific knowledge, taken from one of sixteen subject areas that are part of the South Coast Doctoral Training Programme, so that you have both methodology and subject specific knowledge and understanding.

The aims of the Masters in Social Research Methods are to:

- Enable you to define your PhD research topic within the social sciences and critically defend this approach in a written proposal.
- Provide you with the requisite skills for carrying out in-depth research within social science disciplines.
- Provide you with broad training in social science methodology, including both qualitative and quantitative methods, research design and the philosophy of social science.
- Ensure that you have covered the key debates and issues within the subject area that you will be studying for your PhD.
- Develop skills to enable you to work within an interdisciplinary research environment.
- Develop skills in critical and evaluative thinking.
- Enable you to develop transferrable skills through oral and written coursework and exams.
- Support you in becoming an independent researcher.

## **Programme Learning Outcomes**

---

### **Knowledge and Understanding**

---

This programme will give you the ability to demonstrate knowledge and understanding of a range of research methodologies across the social sciences, as well as detailed subject specific knowledge and understanding through an interdisciplinary perspective. Specifically, having successfully completed this programme you will be able to demonstrate knowledge and understanding of:

- A1. The principles of research design and strategy, and the choice of research method.
- A2. The dominant traditions in the philosophy of social science and how these have shaped substantive research within the social sciences.
- A3. The advantages and disadvantages of the main data collection techniques used in the social sciences.
- A4. Principles of scientific method and the impact of measurement, collection and analysis strategies on the reliability, validity and generalisability of research outputs.

- A5. A range of quantitative data analysis techniques used both within and outside of your research area.
- A6. A range of qualitative data collection and analysis methodologies used both within and outside of your research area.
- A7. The key debates within your topic area from an interdisciplinary perspective.
- A8. The key theoretical and conceptual approaches within your specific subject area.
- A9. An individual research topic.†

Specific learning outcomes for each subject area are shown within the subject-specific compulsory module outlines.

### ***Teaching and Learning Methods***

A range of teaching and learning methods will be used. Lectures perform a central role within teaching (A1 to A8), alongside tutorials (A1 to A4), seminars (A4 to A8), group work (A7) and computer workshops (A5). You will also be supervised in one to one sessions (A9). Independent study is expected to support learning throughout the programme. Sessions with non-academic experts will broaden the understanding of social research in action.

### ***Assessment methods***

A range of assessment methods will be employed throughout. These include coursework (A1 to A8) and a dissertation (A9). A range of types of coursework may be employed to assess learning outcome A7, while depending on the subject pathway chosen there may be examinations (A8).

## **Programme Structure**

---

The Masters in Social Research Methods has an overarching structure, within which there are 19 pathways. Students will be placed on one of these pathways, depending on the subject area of the student and where the student will be based for their PhD study within the SCDTP. This will be agreed during selection into the SCDTP between yourself, your supervisors and the SCDTP management group. The pathways are all based in Southampton only, apart from where noted below:

1. **Area Studies (with their PhD research to be conducted in Portsmouth)**
2. **Criminology**
3. **Demography**
4. **Economic and Social History**
5. **Economics**
6. **Education**
7. **Gerontology**
8. **Human Geography**
9. **Linguistics**
10. **Management (with their PhD research to be conducted in Southampton)**
11. **Management (with their PhD research to be conducted in Brighton): this pathway will not be running in 2018/19**
12. **Politics and International Relations**
13. **Psychology (with their PhD research to be conducted in Southampton)**
14. **Psychology (with their PhD research to be conducted in Portsmouth)**
15. **Social Policy (with their PhD research to be conducted in Southampton)**
16. **Social Policy (with their PhD research to be conducted in Brighton): this pathway will not be running in 2018/19**
17. **Health Research**
18. **Social Statistics**
19. **Sociology**

Within each pathway there are three types of module, relating to a different aspect of training:

- A. Research methods training**
- B. Interdisciplinary training**
- C. Subject specific training, including the dissertation.**

Although there is a general structure to the programme, there are exceptions to this that will be detailed within each pathway below.

The year is divided into two semesters, each of 12 teaching weeks. In the week before the first semester begins you will meet with your potential PhD supervisors to conduct a Training Needs Analysis (TNA) which will inform your choice of modules over the year. The programme of study consists of a combination of compulsory and option modules and a dissertation, to be completed over the summer months. Each module is worth 5 or 10 ECTS (10 or 20 CATS) points, and a total of 60 ECTS (120 CATS) points are required to complete the taught component of the programme. Exceptionally, there are some modules in particular subject areas that are worth 3.75 or 7.5 ECTS (7.5 or 15 CATS).

In addition to the compulsory modules, research method option modules and thematic cluster pathway modules, students will also have the ability to choose subject specific masters level modules from across all the institutions, based on the TNA, as outlined below in the Programme Structure. These modules will be selected based on the requirements for the proposed PhD research and within the constraints of timetabling and availability. Information about pre- and co-requisites is included in individual module profiles.

## **Programme details**

The structure of each of the pathways within the programme and the modules currently offered are set out below. Of the modules shown against each year of your programme, some are compulsory (i.e. enrolment is automatic) and others can be taken as options. The option modules listed within each pathway constitute an indicative list. There will always be choice but the options might vary each year, depending on curriculum planning and staff availability. The programme is normally studied over 27 months part-time. The taught component of the programme consists of 30 study weeks divided into two semesters during which time students study up to 12 modules up to a value of 60 ECTS/ 120 CATS. Following the taught component, students undertake a six-month period of supervised research for a Master's dissertation at a value of 30 ECTS/ 60 CATS.

## **Progression Requirements**

The programme will follow the University's regulations for ***Progression, Determination and Classification of Results: Undergraduate and Integrated Masters Programmes*** or the University's regulations for ***Progression, Determination and Classification of Results: Standalone Masters Programmes*** as set out in the General Academic Regulations in the University Calendar:

This includes modules taught and convened at the Universities of Brighton and Portsmouth for those registered on the Masters in Social Research Methods.

The MSRM is a Masters for only those who are funded on a 1+3 award by the South Coast Doctoral Training Programme. In order to progress onto the +3 part of the award to study for a PhD you will have to attain a

mean mark for the taught part of the MSRM programme of 60 or above. This will be calculated after any referrals or supplementary assessments have occurred, following the regulations as noted in the University Calendar, noted above. If you do have to take an assessment during the referral period this may delay your entry onto the PhD programme, with a resultant pause in your SCDTP funding. Continued funding of the PhD is dependent on the successful completion of the MSRM, including the dissertation.

## Intermediate exit points

You will be eligible for an interim exit award if you complete part of the programme but not all of it, as follows:

The general structure (although there are some exceptions detailed below) consists of 5 compulsory basic research methods modules (RESM6001, RESM6002, RESM6003, RESM6004 and RESM6005). These modules are worth 5 ECTS/ 10 CATS each and have a total value of 25 ECTS/ 50 CATS. There is also a choice of at least one module out of three intermediate research methods modules, RESM6006, RESM6007 and RESM6305 (5 ECTS/10 CATS each).

You will take one out of five interdisciplinary modules. The module that you will take will be based on the SCDTP Thematic Cluster Pathway (TCP) that you were selected onto within the SCDTP. Each of these modules is worth 5 ECTS/ 10 CATS.

The remaining modules will be related to the subject that is being studied. Most pathways have some compulsory modules which will ensure you are prepared for your PhD, detailed in each of the pathways noted below. Remaining modules will be taken as options, based around your training needs analysis and depending on the number of ECTS/ CATS remaining.

You will also write a dissertation over the summer based within the subject area that you are studying. This will be on a subject agreed between yourself and your supervisors and is likely to be related to your proposed PhD research topic. This is worth 30 ECTS/ 60 CATS.

### 1. Area Studies

If you are conducting your PhD within Area Studies at the University of Portsmouth you will follow the Masters programme pathway detailed in this section.

You will take all basic research methods modules (RESM6001 to RESM6005) and choose at least one intermediate research methods module (RESM6006, RESM6007 or RESM6305). These are all taught at the University of Southampton.

You will take one Thematic Cluster Pathway module (5 ECTS/ 10 CATS), which will be taught across all three partner universities (Brighton, Portsmouth and Southampton). The module that you will take will be that which is aligned to the Thematic Cluster Pathway that you were selected onto within the SCDTP.

There are two subject area compulsory modules. These are RESM6024 Concepts and Methodologies for Area Studies (10 ECTS/ 20 CATS) and RESM6025 Area Studies: Research Techniques and Data Sources (5 ECTS/ 10 CATS). These will be taught at the University of Portsmouth.

You will select option modules up to a value of 10 ECTS/ 20 CATS, based on your Training Needs Analysis.

You will be enrolled in the Area Studies masters dissertation module (RESM6019). Your dissertation will be supervised within the University of Portsmouth, but you may have a co-supervisor from the partner Universities if it is agreed to be useful to do so.

## 2. Criminology

If you are conducting your PhD within Criminology at the University of Southampton you will follow the Masters programme pathway detailed in this section.

You will take all basic research methods modules (RESM6001 to RESM6005) and choose at least one intermediate research methods module (RESM6006, RESM6007 or RESM6305). These are all taught at the University of Southampton.

You will take one Thematic Cluster Pathway module (5 ECTS/ 10 CATS), which will be taught across all three partner universities (Brighton, Portsmouth and Southampton). The module that you will take will be that which is aligned to the Thematic Cluster Pathway that you were selected onto within the SCDTP.

There are two subject area compulsory modules, each worth 10 ECTS/ 20 CATS. These are CRIM6001 Criminal Justice and CRIM6003 Criminal Behaviour. These will be taught at the University of Southampton.

You will select one option module, worth 5 ECTS/ 10 CATS, based on your Training Needs Analysis.

You will be enrolled in the Criminology masters dissertation module. Your dissertation will be supervised within the University of Southampton, but you may have a co-supervisor from the partner Universities if it is agreed to be useful to do so.

### **3. Demography**

If you are conducting your PhD within Demography at the University of Southampton you will follow the Masters programme pathway detailed in this section.

You will take all basic research methods modules (RESM6001 to RESM6005). You will also take Quantitative Methods 2 (RESM6007) as a compulsory module. The remaining two intermediate research methods modules can be taken as option modules (RESM6006 or RESM6305). These are all taught at the University of Southampton.

You will take one Thematic Cluster Pathway module (5 ECTS/ 10 CATS), which will be taught across all three partner universities (Brighton, Portsmouth and Southampton). The module that you will take will be that which is aligned to the Thematic Cluster Pathway that you were selected onto within the SCDTP.

There are three subject area compulsory modules, each worth 5 ECTS/ 10 CATS. These are DEMO6020 Demographic Methods 1, DEMO6021 Understanding Population Change and DEMO6022 Demographic Methods 2. These will be taught at the University of Southampton.

You will select option modules up to a value of 10 ECTS/ 20 CATS, based on your Training Needs Analysis.

You will be enrolled in the Demography masters dissertation module. Your dissertation will be supervised within the University of Southampton, but you may have a co-supervisor from the partner Universities if it is agreed to be useful to do so.

## 4. Economic and Social History

If the topic of your PhD is Economic and Social History then you may be in a variety of different departments across the University of Southampton. If this is the topic of your PhD then you will follow the Masters programme pathway detailed in this section.

You will take all basic research methods modules (RESM6001 to RESM6005) and choose at least one intermediate research methods module (RESM6006, RESM6007 or RESM6305). These are all taught at the University of Southampton.

You will take one Thematic Cluster Pathway module (5 ECTS/ 10 CATS), which will be taught across all three partner universities (Brighton, Portsmouth and Southampton). The module that you will take will be that which is aligned to the Thematic Cluster Pathway that you were selected onto within the SCDTP.

There are no compulsory subject area modules, with all subject modules taken as option modules. You will therefore take 25 ECTS/ 50 CATS of option modules within the Masters programme. These option modules will be selected based on your Training Needs Analysis.

You will be enrolled in the masters dissertation module that is most appropriate to your topic (i.e. this may be Economics, Demography or History). Your dissertation will be supervised within the University of Southampton, but you may have a co-supervisor from the partner Universities if it is agreed to be useful to do so.

## 14. Psychology (Portsmouth)

The modules available here are RESM6006, Qualitative Methods 2, RESM6305, Mixed Methods and RESM6010, Group Comparisons. These are all taught at the University of Southampton.

You will take one Thematic Cluster Pathway module (5 ECTS/ 10 CATS), which will be taught across all three partner universities (Brighton, Portsmouth and Southampton). The module that you will take will be that which is aligned to the Thematic Cluster Pathway that you were selected onto within the SCDTP.



There are two subject area compulsory modules, each worth 10 ECTS/ 20 CATS. These are PSYC6046, Advanced Statistics in Psychology and PSYC6109, Concepts and Skills. These will be taught at the University of Southampton.

## Support for student learning

---

There are facilities and services to support your learning, some of which are accessible to students across the University and some of which will be geared more particularly to students in your own particular Faculty or discipline area. These are the facilities available at the University of Southampton. The Universities of Brighton and Portsmouth have their own facilities and services that they will offer you if you are to study for your PhD in these locations. You will be informed about these during induction.

The University provides:

- library resources, including e-books, on-line journals and databases, which are comprehensive and up-to-date; together with assistance from Library staff to enable you to make the best use of these resources
- high speed access to online electronic learning resources on the Internet from dedicated PC Workstations onsite and from your own devices; laptops, smartphones and tablet PCs via the Eduroam wireless network. There is a wide range of application software available from the Student Public Workstations.
- computer accounts which will connect you to a number of learning technologies for example, the Blackboard virtual learning environment (which facilitates online learning and access to specific learning resources)
- standard ICT tools such as Email, secure filestore and calendars.
- access to key information through the MySouthampton Student Mobile Portal which delivers timetables, Module information, Locations, Tutor details, Library account, bus timetables etc. while you are on the move.
- IT support through a comprehensive website, telephone and online ticketed support and a dedicated helpdesk in the Hartley Library.
- Enabling Services offering support services and resources via a triage model to access crisis management, mental health support and counselling. Support includes daily Drop In at Highfield campus at 13.00 – 15.00 (Monday, Wednesday and Friday out of term-time) or via on-line chat on weekdays from 14.00 – 16.00. Arrangements can also be made for meetings via Skype.  
assessment and support (including specialist IT support) facilities if you have a disability, long term health problem or Specific Learning Difficulty (e.g. dyslexia).
- the Student Services Centre (SSC) to assist you with a range of general enquiries including financial matters, accommodation, exams, graduation, student visas, ID cards
- Career and Employability services, advising on job search, applications, interviews, paid work, volunteering and internship opportunities and getting the most out of your extra-curricular activities alongside your degree programme when writing your CV
- Other support that includes health services (GPs), chaplaincy (for all faiths) and 'out of hours' support for students in Halls and in the local community, (18.00-08.00)
- A Centre for Language Study, providing assistance in the development of English language and study skills for non-native speakers.
- In addition, students based at the Universities of Brighton or Portsmouth will also have access to the learning facilities provided by that institution.

The Students' Union provides

- an academic student representation system, consisting of Course Representatives, Academic Presidents, Faculty Officers and the Vice-President Education; SUSU provides training and support for all these representatives, whose role is to represent students' views to the University.
- opportunities for extracurricular activities and volunteering
- an Advice Centre offering free and confidential advice including support if you need to make an academic appeal
- Support for student peer-to-peer groups, such as Nightline.

Associated with your programme you will be able to access:

- Module lead's support. Module leads will be available at designated times during the week to discuss issues related to the particular modules you are studying at the time. This will be in addition to class contact time.
- Personal Academic Tutor (PAT). As soon as you register on this programme, you will be allocated a PAT. S/he is a member of the academic team and will be available to discuss general academic issues related to the programme.
- Senior Tutor. Within each Department there is a Senior Tutor who supports student learning and is available to discuss issues related to the programme.
- Module handbooks/outlines. These will be available at the start of each module (often in online format). The Handbook includes the aims and learning outcomes of the module, the methods of assessment, relevant background material to the module and a session-by-session breakdown of the module together with appropriate reading lists.
- Within the Faculty, administrative support is provided by your Student Office which deals with student records and related issues and with queries related to your specific degree programme.
- Within the SCDTP, there will be administrative and academic support to discuss any issues that you may be having with the programme overall or specific modules.

## Methods for evaluating the quality of teaching and learning

---

You will have the opportunity to have your say on the quality of the programme in the following ways:

- Completing student evaluation questionnaires for each module of the programme
- Acting as a student representative on various committees, e.g. Staff: Student Liaison Committees, Faculty Programmes Committee OR providing comments to your student representative to feed back on your behalf.
- Serving as a student representative on Faculty Scrutiny Groups for programme validation
- Taking part in programme validation meetings by joining a panel of students to meet with the Faculty Scrutiny Group
- Students at the Universities of Brighton and Portsmouth will also have the opportunity to give additional feedback via local mechanisms

The ways in which the quality of your programme is checked, both inside and outside the University, are:

- Regular module and programme reports which are monitored by the Faculty
- Programme validation, normally every five years
- External examiners, who produce an annual report
- A national Research Excellence Framework (our research activity contributes directly to the quality of your learning experience)
- Higher Education Review by the Quality Assurance Agency for Higher Education
