Programme Overview

Brief outline of the programme

To what extent can policies remove social problems such as poverty, addiction or anti-social behaviour? Are more crimes committed in unequal societies? How do we protect citizens against social risks and how do we penalise them for specific actions? How does our perception of what is appropriate or wrong change over time and between cultures?

When studying Social Policy and Criminology you will engage with the question of how societies make and recognise social problems and how and when individuals are seen as deviant. You will explore how principles of social justice influence our view of problems and of the appropriate solutions. Health, education and welfare programmes as well as systems of criminal justice have been adopted by most societies. As a BSc Social Policy and Criminology student you will investigate why this is the case and how they work.

Your contact hours will vary depending on your module/option choices. Full information about contact hours is provided in individual module profiles.

Learning and teaching

Teaching takes place during two semesters, the first running from October to February and the second from February through to May. Eight subject modules (compulsory and option) are taken per year – four per semester.

Teaching comprises both lectures (one to three per week, depending on the module) and weekly or fortnightly small-group classes. Towards the final year modules become more student-led, and some third year modules are based on student presentations and group projects. In a typical semester, you would spend about 12 hours per week attending lectures and classes. In addition, we expect about 28 hours of self-study (preparing for classes, writing essays and so on), bringing the weekly total to 40 hours.

Assessment

Assessment in year one is primarily by examination and essay, although the Studying the Social World assessment relates to the skills developed (e.g. a group presentation).

Most year two modules are also assessed by examination, but in combination with other methods of assessment such as short essays, group and individual presentations and/or poster presentations.

In year three, most modules are assessed either by a single long essay or by a shorter essay in combination with individual or group presentations, poster presentations or some other method of assessment.

Tailoring your degree (Minor subject)

The structure of your degree programme allows you to exercise choice in each year of study. You can exercise this choice in a number of ways.

- · You can use these modules to deepen your knowledge of your main subject.
- You can combine additional modules from your main subject with modules from other disciplines or choose from a selection of interdisciplinary modules.
- You can choose modules that build into a minor pathway, the title of which will be mentioned in your degree transcript. Details of the minors available and the modules that are included can be found at www.southampton.ac.uk/cip.

- Develop an understanding of the criminal justice system, its institutions and those involved in the system and its representations, and the political, social and economic context within which it operates;
- Develop your capacity for the critical evaluation of theoretical perspectives and empirical evidence in the fields social policy and criminology, and for the application of such perspectives and evidence in your own work;
- Develop your capacity to undertake independent social enquiry, using appropriate methodologies;
- Develop your skills in written and oral communication, the use of information technology, the analysis of quantitative and qualitative data, and working co-operatively in groups to achieve designated outcomes;
- · Develop your ability to work independently in identifying and analysing the subjects of your enquiry.

Part I

Typical programme content

This degree equips you with an in-depth understanding of sociological and criminological approaches to crime and develops your wider sociological knowledge and skills. You will be given a thorough grounding in research methods and theoretical perspectives, and learn how our diverse and complex societies respond to behaviours regarded as criminal and deviant alongside notions of what 'normal' life is, or should be.

Programme details

The structure of the programme and the modules currently offered are set out below. Of the modules shown against each year of your programme, some are compulsory (i.e. enrolment is automatic) and others are optional. Against each year, you are directed to which modules are compulsory and which are optional. The optional modules listed constitute an indicative list. There will always be choice but the options might vary between years. The option modules shown below constitute an indicative list; there will always be choice but the options might vary between years. A full list of modules and rules will be available to you via the Student Record Self-Service system once you enrol at the University.

When studying Social Policy and Criminology together you will engage with question of how societies make and recognise social problems and how and when individuals are seen as deviant. You will explore how principles of social justice influence our view of problems and of the appropriate solutions. Health, education and welfare programmes as well as systems of criminal justice have been adopted by most societies. As a BSc Social Policy and Criminology student you will investigate why this is the case and how they work.

The programme comprises three parts, each corresponding to one year of full-time study. You will normally have to take 4 modules (30 ECTS/60 CATS) each semester (i.e. 8 modules (60 ECTS/120 CATS) in each year of the programme. Each CATS credit can be considered as the equivalent of approximately ten hours of study. All the modules offered in this programme (except the dissertation) are 7.5 ECTS/15 CATS modules. This means that each module comprises around 150 hours of study divided into contact time (e.g. lectures, seminars, workshops) and non-contact time when you will be engaged in directed study (preparation for classes) and independent study when you will be involved in producing assignments and preparing and taking examinations.

The dissertation is a 15 ECTS/30 CATS module comprising 300 hours of study divided into contact time (workshops and supervisory tutorials) and a significantly larger portion of hours allocated to non-contact, independent study time. This is because the dissertation is designed to foster independent inquiry and is the culmination of three years of study, enabling you to apply theories and methods explored at all years and to examine one area of the discipline in detail.

Support for student learning

There are facilities and services to support your learning some of which are accessible to students across the University and some of which will be geared more particularly to students in your particular Faculty or discipline area

The University provides:

- library resources, including e-books, on-line journals and databases, which are comprehensive and up-to-date; together with assistance from Library staff to enable you to make the best use of these resources
- high speed access to online electronic learning resources on the Internet from dedicated PC Workstations onsite and from your own devices; laptops, smartphones and tablet PCs via the Eduroam wireless network. There is a wide range of application software available from the Student Public Workstations.
- computer accounts which will connect you to a number of learning technologies for example, the Blackboard virtual learning environment (which facilitates online learning and access to specific learning resources)
- standard ICT tools such as Email, secure filestore and calendars.
- access to key information through the MySouthampton Student Mobile Portal which delivers timetables, Module information, Locations, Tutor details, Library account, bus timetables etc. while you are on the move.
- IT support through a comprehensive website, telephone and online ticketed support and a dedicated helpdesk in the Hartley Library.
- Enabling Services offering support services and resources via a triage model to access crisis management, mental health support and counselling. Support includes daily Drop In at Highfield campus at 13.00 15.00 (Monday, Wednesday and Friday out of term-time) or via on-line chat on weekdays from 14.00 16.00. Arrangements can also be made for meetings via Skype.
- assessment and support (including specialist IT support) facilities if you have a disability, long term health problem or Specific Learning Difficulty (e.g. dyslexia).
- the Student Services Centre (SSC) to assist you with a range of general enquiries including financial matters, accommodation, exams, graduation, student visas, ID cards
- Career and Employability services, advising on job search, applications, interviews, paid work, volunteering and internship opportunities and getting the most out of your extra-curricular activities alongside your degree programme when writing your CV

- Module handbooks/outlines. These will be available at the start of each module (often in online format). The Handbook includes the aims and learning outcomes of the module, the methods of assessment, relevant background material to the module and a session-by-session breakdown of the module together with appropriate reading lists.
- Within the Faculty, administrative support is provided by your Student Office which deals with student records and related issues and with queries related to your specific degree programme.

Methods for evaluating the quality of teaching and learning
