LASTING POWERS OF ATTORNEY (LPA)

Needing help to make decisions about your financial and welfare matters can happen to you at any age, time and for different reasons.

Your Next of Kin **DOES NOT** have an automatic legal right to help you when you are incapacitated.

If you are not prepared for possible mental incapacity you are at risk of losing control over your financial and welfare decisions.

You must decide and prepare in advance who will help you, how they will help you and when they will help you.

Your instructions must be detailed in a legally binding document called a Lasting Power of Attorney (LPA) England and Wales.

LPAs must be registered with the Office of the Public Guardian before they can be used.

HOW WE CAN HELP YOU

We will help you to understand your options.

We will support you by dealing with all correspondence relating to the completion of the LPA.

We will support you by dealing with all correspondence relating to the registration of the LPA with the Office of the Public Guardian (OPG).

We are appointed by the Lord Chancellor and have authority to act as Attorney on your behalf if you so wish.

We only charge to cover our overheads we are a not for profit organisation.

As a registered charity we can reduce our fee to offer support if you have proven limited income or assets.
