Programme Overview

Brief outline of the programme

The Masters with Integrated Preparatory Study (MIPS) is an integrated programme which is designed to equip talented international students to prepare for and take a University of Southampton taught masters degree. The programme has two parts; in Part I you will acquire the academic and English language skills you will need to have success on a taught masters programme and in Part II you will join one of specified range of masters programmes at the University.

This programme specification is solely concerned with Part I of the programme.

Learning and teaching

You will be helped to achieve the learning outcomes of the programme by a range of learning and assessment methods.

• Lectures and Seminars: these activities are the core of the teaching. Lectures are teacher led and will provide you with the knowledge and support you need for your future masters degree programme. In classes for the subject specific modules you will develop you understanding of the concepts and

- approaches used in the teaching of the discipline you will study in more depth in your masters programme.
- Independent study: you will be expected to spend a significant amount of time working independently
 on a range of tasks including preparatory tasks for classes, carrying out personal research and
 completing assignments.
- Giving individual and group presentations: presenting your work orally will be an important aspect of studying at masters level. Preparing and giving presentations not only helps you learn about your subject but also allows you to improve the specialised English language skills you will need. Preparing and delivering group presentations allow you to experience the opportunities and challenges of working as a team.
- Information Technology (IT): the Southampton pre- masters integrates IT supports into its teaching. The principle IT support which is used is *Blackboard*, a virtual learning environment (VLE) which is used distribute and curate materials for teaching.

Assessment

A varied range of assessment methods is central to this programme, besides ensuring that you have reached the level required to be a successful student at masters level it will help develop your intellectual flexibility for use both in your studies and your future career.

The following assessments methods are typically used;

- Essays, reports and other writing assignments from 500 to 4000 words in length
- Examinations
- Individual presentations
- Group projects & presentations
- · Observed seminars
- · Reflective assignments including online writing.

- Enhance your reading, writing, speaking and listening skills in the English language so that you are able to express postgraduate level thinking through your written and verbal communication

Teaching and Learning Methods

In Part One of the Masters with Integrated Preparatory Study programme your academic and English language skills will be enhanced through the use of communicative teaching activities such as seminars, presentations, guided independent study and preparation for written assignments.

You will also take one or more subject specific modules allowing you to experience learning about a topic related to your masters programme in an English speaking environment.

Feedback will be given to enable you to identify your strengths and weaknesses and to continue to develop your language and academic skills effectively. Tutors give extensive guidance, especially through recommendations of reference and source materials. You will learn to take more responsibility for your own learning as you progress through the programme.

Assessment methods

Your knowledge and understanding will be assessed in a variety of ways, which include examinations and coursework. Examinations assess your ability to apply your knowledge and understanding, often asking you to present an argument within a limited period of time. Coursework may include tasks such as long essays, class presentations, and seminars. These tasks test your ability to apply your knowledge and understanding of academic language and study skills, and to construct an in-depth argument.

Subject Specific Intellectual and Research Skills

Having successfully completed this programme you will be able to:

- B1. Recognise and understand academic and professional vocabulary
- B2. Identify appropriate sources of information for your subject area
- B3. Locate resources for your subject area in the relevant libraries and online repositories
- B4. Interpret and analyse a range of information from different sources
- B5. Extract, paraphrase and synthesise key information from written and spoken sources
- B6. Present reasoned and structured arguments, both orally and in written form
- B7. Express facts, concepts and arguments clearly using appropriate language
- B8. Understand and present detailed reasoning.

Teaching and Learning Methods

The structure and content of Part One of the Masters with Integrated Preparatory Study programme gives you the opportunity to develop a range of cognitive skills which are developed in communicative learning activities such as in seminars, presentations, and discussions. Lectures develop the skills of processing and summarising information (internally and through note-taking and discussion). Critical thinking skills will be developed as you learn how to recognise subjectivity, analyse arguments objectively and to apply these skills in your own work. You further develop cognitive skills through researching and writing essays.

Regular feedback will be given to help you to identify any gaps in your cognitive skills. This allows you to develop your skills effectively by building on your strengths and addressing weaknesses or gaps in conveying subject specific knowledge, or processing relevant research.

Assessment methods

Assessment methods include examinations and coursework. Examinations, whether written or oral, test your overall thinking skills in conditions where time and support for reflection are limited. Coursework assessment allows you to monitor your progress as well your testing your final results against the learning outcomes of the module concerned.

Transferable and Generic Skills

Having successfully completed this programme you will be able to:

- C1. Carry out a piece of independent research
- C2. Present reasoned and structured arguments, both orally and in written form
- C3. Identify, select and critically draw upon a range of printed and electronic sources
- C4. Extract and synthesise key information from written and spoken sources
- C5. Use selected electronic tools such as PowerPoint to enhance your presentations
- C6. Organise your study time effectively
- C7. Demonstrate interpersonal skills whilst working with others in the investigation of problems, and in the presentation of arguments and evidence

Teaching and Learning Methods

Your key skills will be developed through tutor-led and student-led seminars and tutorials, library sessions, group projects and independent research.

Assessment methods

You will be asked to demonstrate your key skills through participating in individual and group presentations, class exercises, group work and a piece of independent research. Progression is recognised in the assessment scheme, which tests key skills at appropriate levels of study.

Subject Specific Practical Skills

Having successfully completed Part One of the Masters with Integrated Preparatory Study programme you will have the study skills required to study your chosen subject at Masters level at the University of Southampton.

Disciplinary Specific Learning Outcomes

The Part One of the Masters with Integrated Preparatory Study programme is intended to enhance your study skills for your chosen Masters programme which will have its own specific learning outcomes.

Programme Structure

Special Features of the programme

The Masters with Integrated Preparatory Study has two entry points; September (two semesters) or January (one semester).

Entering the programme in;

- September for two semesters provides you with 24 months of integrated study
- January for one semester provides you with 18 months of integrated study.

Entry Points for MA Design and MSc Advanced Mechanical Engineering

If you are preparing for any of the <u>MA Programmes</u> at Winchester School of Art, you can only take the 24 month Masters with Integrated Preparatory Study programme.

If you are preparing for any of the MSc Engineering Masters Programmes, you can only take the 18 month Masters with Integrated Preparatory Study programme.

If you have chosen any other Masters programmes for part II, your entry point will depend on:

- vour English language skills (as shown on a valid Secure English Language Test [SELT])
- the quality and relevance of your bachelor's degree.

Programme Details

The programme is divided into modules. Single modules have a credit value of up to 15 CATS (Credit Accumulation Transfer Scheme or 7.5 ECTS (European Credit Transfer & Accumulation Scheme). Double modules have a value of 30 CATS (15ECTS). Each CATS credit refers to 10 hours of learning. Some of that learning is face to face with your tutor and the remainder is independent study.

All your modules are 'core' modules, which mean that you must take and pass have to each module in order to progress to part II, of the Masters with Integrated Preparatory Study i.e. your chosen Masters programme.

Additional Costs
