# **LAUNCH**

On the 26th of February 2024, the Launch Event commemorating the official kick-off of the Legal Clinic took place. The event featured a speech and ribbon-cutting ceremony by the Solicitor General, Robert Courts KC MP. Also in attendance were the Dean, Professor Jo Swaffield, Professor Jane Falkingham from the VC office, and our Head of School, Professor Werner Scholtz. After the ceremony, the Legal Clinic Committee and advisors in attendance had the opportunity to attend a networking session and a panel promoting government legal careers.





Global Legal Clinic Student Committee President Sophia Hamdam said the Clinic will help people hit hardest by legal aid cutbacks and the cost-of-living crisis. She stated: "Anyone can come to us for free legal advice, and we will even go to court to support our clients. It will be an invaluable experience for us all on the degree."

# HAMPSHIRE AND ISLE OF WIGHT PRO BONO COMMITTEE

On Thursday the 23rd of November 2023, the Law School hosted a hybrid event aimed at inviting stakeholders to decide whether they wished to form a regional pro bono committee. The Law School's Legal Clinic Director, Dr Omar Madhloom, organised this event with support from Toby Brown, a barrister at South Square Chambers and Chair of the steering group of the Attorney General's Pro Bono Committee of England & Wales, and Chair of the UK Pro Bono Week organising committee, and Charlotte Mallin-Martin, a barrister at Guildhall Chambers, and the Western Circuit's pro bono officer.

Those in attendance unanimously voted in favour of establishing a regional pro bono committee and elected Mo Aldridge, solicitor and partner at Jasper Vincent Solicitors (and current President of the Hampshire Law Society) and Dr Madhloom as Co-Chairs of the Committee. HHJ Glen and HHJ Levey kindly agreed to act as honorary presidents. The Committee's membership comprises barristers, solicitors, university law clinics, and third sector organisations, and aimed to promote access to justice in the community.



# LIVE CLIENT CASES

One of the main components of the Global Legal Clinic is our live client clinic. Launched in February of 2024, this exciting experience has allowed student case workers to assist members of the public with their legal issues spanning serval areas of law including Housing, Employment and Contract disputes. Giving our students hands on experience combating legal issues and developing both their soft and hard skills like interviewing skills, legal writing. Over the past year we have helped over 100 clients successfully supporting them through their legal issues or signposting them to onto available support in the area. This will continue to be a staple of the clinic going forward and we will continue to support as many clients as possible.

# **JLAP**



# OTHER CLINICS

#### 1. A-Law

The UK Centre for Animal Law (A-Law) is a charity that brings together lawyers and other professionals interested in animal protection law to share experience and to harness that expertise for the benefit of animals. Our clinic students have had the opportunity to assist with research for the A-Law podcasts and to create posts for A-Laws social media platforms. #### 2. ELF


The clinic has proudly collaborated with The Environmental Law Foundation to provide research support for their varying pieces. This included research on the rights of rivers. The Rights of rivers project involved researching pollution in the River Uck.

#### 3. Enterprise

The Legal Clinic held its first pop-up at the Sir James Matthews Building, with the Student Enterprise Junction, on the 15th of July 2024. The initiative was organized in the form of a drop-in clinic, where student entrepreneurs could consult with clinic advisers and discuss commercial issues that are affecting their business ventures. A group of five advisers participated in the pop-up, under the supervision of Dr Omar Madhloom, and with the support of Mr Tom Simmonds, the Head of Student Enterprise and Events.

The advisers took turns to meet with clients, interview them and understand their expectations from the drop-in service. The clients' concerns focused on the needs of upcoming businesses, such as the process of registering with Companies House, formulating shareholders' agreement and seeking intellectual property protection for their products. Each meeting would be followed by a brief consultation with the supervisor, who directed the advisers towards relevant resources, before they drafted the letter of advice. Differing from the traditional live-client route, the drop-in clinic provided a speedier route for clients to meet with advisers and obtain directions to helpful resources to resolve their concerns. The initiative also allowed advisers to develop a distinct set of interviewing skills and learn to formulate questions with speed and sharpness.



### **INTERNSHIPS**

#### SARC:

In February of 2024, the Clinic interviewed 20 student caseworkers and selected 6 to volunteer with the Southampton Advice and Representation Centre (SARC).

SARC specialise in welfare benefits and employment law advice, and our students stand to gain a wealth of hands-on experience.

# HODGE JONES & ALLEN SOLICITORS

# CITIZENS ADVICE

Following a competitive application process, six students have commenced their training to become Gateway Assessors with Citizens Advice Southampton. Upon completion of the required training materials, each student is paired with an experienced mentor to observe and learn from in practice. Their responsibilities are gradually expanded on a weekly basis, enabling them to take on an increasingly active role in supporting client cases. This placement offers valuable, hands-on experience with issues typically beyond the scope of the Clinic—such as immigration and debt—thereby enhancing and complementing the skills they develop through their clinical work.

"When you join Citizens Advice, you become part of the family. Everyone is happy to help you and show you what to do. You can learn from different people who have extensive experience and knowledge on different areas of the law you would not normally cover at university. # FULKRUM CONTRACT REVIEW

With the clinic's connections to many organisations, we were able to offer our students the opportunity to review legal contracts for an energy company. The clinic ran a series of workshops where students worked in groups to discuss and review, to write up their findings, and then discuss during a final workshop. In December we received a kind donation to fund student internships, reviewing real life legal contracts and reporting their findings directly to their inhouse legal team.



### **GPBB EXTERNSHIP**

Our students were selected to complete an internship with the Global Pro Bono Bar Association (incorporated as a recognized 501(c)(3) nonprofit organization in the United States) as part of their Global Public Interest Lawyering Program. The Global Pro Bono Bar Association is a non-profit organisation, with members on five (5) continents, which focuses on public interest lawyering on a global scale, and like the Global Legal Clinic, is committed to pro bono work. Students assisted in the program's development and benefitted from a very similar standard of training that will be offered to qualified lawyers.

"This was undoubtedly a unique and valuable opportunity, there is little information available about beginning a pro bono legal practice in this field which is what makes this internship stand out. 

# INTERNATIONALISATION

#### Clinique de Montpellier

Our collaboration with Clinique de Montpellier consisted of a student exchange whereby three UoS students worked on Montpellier client cases and 3 Montpellier students worked on Southampton client cases. In addition to this, we included the same Montpellier students in other ongoing projects with overseas clinics.

#### **GPBBA Projects**
