3. Review and approve

University of Southampton will review and, if appropriate, approve and pay for your request.

4. Get your e-bike

You'll receive your Cyclescheme eCertificate via email. Contact Pure Electric, Southampton to arrange redeeming your eCertificate and collecting your new e-bike.

5. Ride

It's time to put your e-bike to the test! Don't forget to...

- Sign up for your 14 days free cycle insurance with Bikmo
- Undertake your free e-bike digital training with Cycling UK.

6. Decide

You can test your e-bike for free for up to 14 days from collection.

After 14 days, your first repayment will be deducted from your salary and you will enter into your Hire Agreement.

Not for you?

You have 14 days from collection to decide if your new e-bike is right for you. If it isn't - you can take advantage of our simple returns process without paying a penny.

1. Return

Return your e-bike to Pure Electric, Southampton along with its original user guide and any accessories/attachments supplied including the two battery keys and battery charger.

2. Inspection

The e-bike will be inspected by a Pure Electric mechanic. For returns to be valid, the e-bike must be...

- IO0% operational
- Cosmetically 'as new' and free from any signs of crash or deliberate damage

Minimal wear and tear to tyres, handlebar grips/tape, saddle and other touchpoints is acceptable.

3. Return accepted

Pure Electric, Southampton will confirm return of your e-bike and you will not make any salary repayments.

Please note – any e-bike not returned within 14 days from collection or in a damaged/defect condition will not be accepted for return.

In these instances, you will need to retain the e-bike and complete your repayments.

FAQs:

Where can I redeem my eCertificate?

This can only be redeemed in-store at Pure Electric, Southampton.

When does my 14-day trial start?

When you collect your e-bike from Pure Electric, Southampton.

How much can I spend on a e-bike?

Your scheme limit is £2,500. Use the <u>Cyclescheme calculator</u> to see how much your monthly repayments will be.

What happens if I do not return the e-bike within the 14 days?

You will enter into your Hire Agreement and begin making monthly repayments from your salary for the e-bike.

Is it free to return the e-bike within the 14 days?

Yes, the e-bike can be returned for free as per the Terms and Conditions.

How do I access my free e-bike digital training?

All details are provided via e-bike upon successful Cyclescheme application.

What is included in the e-bike digital training?

The training focuses on three key areas: on road cycling skills, basic safety checks and e-bike security.

Do I need to complete the e-bike digital training?

The training is not essential but is beneficial.

What happens if the e-bike is stolen during the 14-day trial period?

If you have taken advantage of the 14 days free insurance from Bikmo, the e-bike will be covered. If you have not insured the bike, you will be liable for full repayment of the e-bike cost.
