Dear University of Southampton,

h h incid I am requesting information pertaining to all serious incident investigations involving the health, wellbeing or welfare of one or more students - a 'serious incident' being an adverse event, with significant harmful or potentially harmful consequences, and/or where the effectiveness of the university response is likely to have a significant impact on the health, wellbeing or welfare of a student, their family and/or the community.

The need for a serious incident report is specifically recognised in UUK's Suicide-Safer Universities (2018) guidance.

t would be muss ... the University conducted a server. investigations following the death of a student, health incident (such as attempted suicide, near misses, parse. and whether in University owned property or not. Additionally, if you nave ... students who were no longer registered with the University, but where you still carried our investigation, that information would also be of interest. In response to our clarifications you confirmed that the aim of your request was to "generate as clear a picture as possible of the university sector's actions in relation to suicide prevention and monitoring" however, you went on to state that you wanted the data for all serious incidents which went well beyond incidents of death, suicide or mental health problems and which required an assessment by the University of the incident in question.

This information you have requested is not held by the University but we have interpreted your questions to relate to and align with the UUK's Suicide-Safer Universities (2018) guidance and our formal statutory obligations in that respect the information is as follows:

b) A report was produced for each incident investigated

c) They all involved a fatality.

d) Over this period, we have shared 7 reports with the Health and Safety Executive, in respect of Coroner's inquests.
