PCRC – Induction process.	Together with public contributors, we have developed an induction process for public contributors and researchers that outlines the support structures, introduces the Project PPI Lead for each research study, identifies a point-of-general PPI contact (Centre PPI Officer) and clarifies mechanisms of remuneration. To allocate funding for PPI in Research and Strategy, including remunerating public involvement and PPI Officer time. To continue following GDPR guidelines as we add more public members to the PPI database.
SPCR & PCRC – strengthening PPI in the Centre.	With the SPCR £5k award, we recruited three core public contributors for a period of 6 months. Core public contributors provided insight and perspective in key aspects of the Centre, including redesigning resources and processes for public involvement, actively participating in the PPI Steering Group, Research Strategy Group and in the Wessex PIN.
