"On the Government side, procedures need to be further developed to *capture the full range* of *governmental research interests* involved, including the natural and social sciences, and the *work on evidence gaps* in relation to public services"

"Government and other public agencies want knowledge that is useful in developing useful applications, including good policy. This may require original research, but it may also entail the systematic use of research resources which have been generated by previous studies, and which require research skills for their analysis."

"Supporting a more systematic **expression of Government's own research needs**:

• There is a need across the *full range of Government Departments* for a more strategic approach in relation to their departmental R&D programmes. This is partly a matter of securing the right levels of resource, but includes *maintaining 'statements of need'*, in terms of the most important research questions confronting the Departments. These will require work across the Government *analytical professions to develop*."





# Universities Policy Engagement Network & GOS ARI Fellows

### Rebuilding a Resilient Britain ARIs

The Rebuilding a Resilient Britain programme was launched during the COVID-19 pandemic, to address aspect of Britain's recovery from the pandemic over the medium-to long-term.

ESRC/ARI Fellows Professor Annette Boaz and Dr Kathryn Oliver, funded by ESRC and working with the Government Office for Science ARI team and with government departmental Chief Scientific Advisers, identified a set of topics and themes based on existing departmental ARIs that should be addressed as a priority. These ARIs were divided into 9 themes, which were addressed by 9 Working Groups consisting of researchers, funding bodies and policy makers.

Each Working Group produced a report, identifying existing evidence, gaps in the evidence base, and key messages around the ARIs (note that the reports are the views of the working group members and are not indicative of government policy). These are linked below.

The reports have been made available online as a resource for academics, policy makers and funders interested in what the groups collated on what is already known; and where the current research gaps seem to be on 9 topics of cross cutting interesting to government departments.

ARIs were identified by UPEN members as a key area of focus for the network in 2019. In the Rebuilding a Resilient Britain programme of work, UPEN were actively engaged in the identification of expertise.

- Clear contact information


- Identify govt interest in your subject matter

### Policy activities

Academics and external organisations working together to co-produce research evidence that addresses an ARI in the form of a policy brief, executive summaries, slidedeck and presentation

Evaluation of past and current interventions around an ARI;

Carry out a survey or conduct interviews to gain qualitative insights on an ARI;

**Policy roundtables, or evidence seminars** (to facilitate knowledge exchange and co-develop ideas) which answer an ARI

**Practitioner meetings** and/or workshops based on an ARI;

Activities to **cultivate** and **enhance relationships between academic and non-academic users/stakeholders** (e.g. network building/consolidating) in relation to a specific ARI;

**Co-design of research-led tools, resources, or toolkits** across a range of multimedia (e.g., building websites or data repositories, creating and disseminating videos) linked to an ARI.

**Stakeholder analysis** related to a specific ARI;
