1. Origin

The Admissions Policies Subcommittee (APSC) reports to the Academic Quality and Standards Committee (AQSC) and, on its behalf, considers the development, implementation, and review of the University's entry qualifications and student admissions policies for all levels of study, ensuring compliance with legislative and statutory requirements and alignment with the relevant aspects of the UK Quality Code.

2. Purpose

To establish, develop and monitor the University's student admissions policies for all levels of study, ensuring such policies comply with relevant legislative and statutory requirements and align with the relevant aspects of the UK Quality Code.

3. Responsibilities and activity

- To establish, develop and monitor the University's student admissions policies for all levels of study, ensuring such policies comply with relevant legislative and statutory requirements and align with the relevant aspects of the UK Quality Code.
- To periodically review the University's student admissions policies in order to ensure they are consistently implemented and remain current, fit for purpose, and support the achievement of the University's Mission and Strategy.

- To consider proposals for changes to admissions regulations and policies, reporting these proposals to the AQSC.
- To promote fairness and consistency in admissions policies and procedures.
- To set benchmark admissions criteria and requirements for both academic and English Language entry qualifications.
- To consider the strategic and cross-school implications of proposals from faculties to amend their entry requirements and report to the AQSC.
- To consider recommendations for the acceptance of new or revised qualifications or English language tests, their equivalency with already accepted qualifications, and any changes to those equivalencies, reporting to the AQSC.
- To report to the Widening Participation Subcommittee any matters relating to widening participation that may be of interest to the group.
