In view of COVID-19, the University has had to make changes to some elements of programme delivery for 2020-21. These changes have included the method of delivery, such as face-to-face and online, and the number of modules available.

The University aims to provide as much of a face-to-face component to your education as prevailing conditions at the time allow, combined with its new blended approach that will develop active independent and group online learning.

As the COVID-19 pandemic develops, the University's response to this and other issues may likewise need to evolve. The University will consult with student representatives as necessary and appropriate and will communicate changes to you as soon as practicable so that you have the information you need to understand how a change may impact you and what steps you need to take next. The University remains committed to supporting you as you learn.

## **Programme Information**

In the light of Covid -19 there are likely to be some changes required for clinical placements and activities. This may involve alterations to the organisation of placements and modalities by which clinical experience and teaching can be delivered. Clinical contact may be limited or refined by the current local conditions in our partner trusts/ GP surgeries and according to government quidance.

As we were unable to run a formative OSCE in year 2 in the academic year 2019/20, the Year 3 OSCE in 2021 will be formative for students on all the BM programmes.

### Notes

- 1. Compensation is allowed between the closed book MCQ, Written and Practical papers, provided the qualifying mark is achieved in each paper.
- 2. The Critical Appraisal is stand-alone, open book component which must be passed without cross-compensation options.
- 3. Referral method is a supplementary assessment of the same format as above.
- 4. Repeat Year (internal) is allowed

Compensation is available in all components of the year one synoptic assessment (provided all qualifying marks are achieved) because the three synoptic papers together comprise a single assessment component. In year two, the additional Critical Appraisal as a stand-alone component of the overall synoptic mark means that cross-compensation is only applicable to the three closed book papers. In both years one and two, students failing to achieve one or more qualifying marks, or failing to achieve the weighted aggregate passmark (after compensation), will be offered a supplementary opportunity comprising three further closed book papers (MCQ, Written, Practical); all three supplementary qualifying marks and the weighted aggregate passmark (after compensation) must be achieved to pass the supplementary assessment. Students failing to achieve the 40% pass mark in the year two Critical Appraisal but passing the closed book papers (MCQ, Written, Practical) will be offered a supplementary opportunity for the Critical Appraisal alone from a new selection of research papers.
