In view of COVID-19, the University has had to make changes to some elements of programme delivery for 2020-21. These changes have included the method of delivery, such as face-to-face and online, and the number of modules available.

The University aims to provide as much of a face-to-face component to your education as prevailing conditions at the time allow, combined with its new blended approach that will develop active independent and group online learning.

### **Programme Information**

The supporting element of the Programmes are the employability skills and careers programme, including the weekly IML seminars given by a practitioner, and the annual law fair. The School intends to run these in an appropriately revised format in 2020/21.

The School also organises an annual debating competition, the LLM Challenge, where eight teams of postgraduates compete against each other on a diverse range of current legal topics. This competition is popular and each year we award a price and certificates for the best team. The School intends to run this Challenge in an appropriately revised format in 2020/21.
